Full Members receive one position on the Board of Directors. Full members may also serve on the Executive Committee as an officer or in an at-large position and are eligible to hold a committee leadership position.

## Sponsoring Member | \$10,000

Sponsoring Members receive one vote on issues before the general membership. Sponsoring Members may also serve on the Executive Committee as an officer or in an at-large position and are eligible to hold a committee leadership position.

## Associate Member | \$5,000

Associate Members receive one vote on issues before the general membership. Associate Members may also serve on the Executive Committee in an at-large position and are eligible to hold a committee leadership position.

## Friend of ARAWC | \$1,000

This membership level is limited to a company with fewer than 100 total employees.
